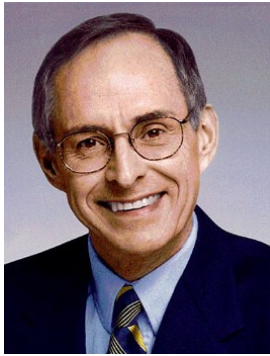

1 WILL OR LIVING TRUST (INTER VIVOS)

You can help bring the teachings of the Light and Sound to future generations with a bequest. Giving to ECKANKAR CANADA through your will or trust can be done in several ways.

You can give

- a specific amount
- a percentage of your estate
- all or part of what remains after your loved ones have been provided for (a bequest of the “residue” of your estate)

If you wish to give ECKANKAR CANADA a gift of real property or tangible property (whether by will or otherwise), please contact ECKANKAR CANADA before making the gift.

Most people leave their estates to family members in their wills or through a living trust (Inter Vivos) that avoids probate. Your personal wishes and situation will determine the best method of giving. Discuss the contents of your will or trust with your beneficiaries. Family members of most ECKists understand how valuable ECKANKAR is to their loved ones and will give their heartfelt support to carrying out your wishes.

Your lawyer can help choose appropriate wording and make sure that issues such as income and estate taxes are considered.

When naming ECKANKAR CANADA in a will or trust, the following designations are recommended:

- ◆ To ECKANKAR CANADA: “ECKANKAR CANADA, Box 39538, RPO White Rock, Surrey, BC V4B 4A4, Canada and its successors in interest.”
- To ECKANKAR CANADA for use in a specific province or territory (for example Manitoba): “ECKANKAR CANADA, Manitoba Region, and its successors in interest.”
- To ECKANKAR CANADA for use in a specific local area (for example, Winnipeg): “ECKANKAR CANADA, Winnipeg Branch, and its successors in interest.”
- To ECKANKAR, Chanhassen, U.S.A. “ECKANKAR, P.O. Box 2000, Chanhassen, MN, 55317-2000 U.S.A. and its successors in interest.” ECKANKAR’s United States federal tax identification number is 88-0108294.
